Payments accepted in a form of check only. Application fees are due at the time of application. Space number and location assigned by NW Ukrainian International Festival. Vendor must have own Pop-up Tent, tables, and other equipment required by fire, building, police or any other City of Bellevue department and organizer. Vendors must agree to be set up a day prior the scheduled open times of the event. Vendors must remain open until scheduled Event finish times – NO EARLY TAKE DOWNS.

Food permits must be submitted to NW Ukrainian International Festival's representative no later than **August 20, 2022** for final vendor approval. No vendors will be accepted for participation in the event after August 20, 2022.
